DISCIPLINARY REGULATIONS of Brno University of Technology

Pursuant to Section 9 para 1 b) and Section 17 para 1 h) of the Act No 111/1998 Coll regarding Institutions of Higher Education and the amendments thereto (Act on institutes of higher education), the Academic Senate of Brno University of Technology decided upon the following Disciplinary Regulations of Brno University of Technology:

Article 1 Disciplinary misdemeanour proceedings

- (1) Pursuant to Section 17 para 1 h) of the Act No 111/1998 Coll regarding Institutions of Higher Education and the amendments thereto (Act on institutes of higher education), (hereinafter "the Act"), these Disciplinary Regulations are internal regulations of Brno University of Technology (hereinafter "BUT").
- (2) A student disciplinary misdemeanour is dealt with by the disciplinary commission of the Faculty, where the student has been enrolled (hereinafter "the disciplinary commission").
 - (3) The disciplinary commission has six members, whose office term is 2 years.
- (4) The disciplinary commission meeting is called in writing by its chairman. The results of the disciplinary commission meeting are deemed valid provided that at least three fifths of the members take part in the meeting.
- (5) The part of the disciplinary commission meeting, where facts of the case are being found out is open to the public.

The summons for the disciplinary commission meeting shall be delivered to the student, whose misdemeanour will be discussed, by personal delivery at least fourteen days before the meeting. The summons can be delivered to the student by personal delivery directly at the faculty, which is in charge to arrange organisational and legal part of the study programme the student has enrolled in, or by the post. The summons shall be considered as delivered on the date of its takeover, on the date of the takeover rejection, or after the expiry of the period of three days after its deposition at the Post office. Should the summons delivery fail, it is put up

on the official faculty board. The date it is put up on the board shall be considered as the date of delivery.

A report on the disciplinary commission meeting shall be kept, which includes all facts relevant for the decision on the penalty proposal. A student, who is present, may comment on them.

(8) The disciplinary commission decides about the penalty proposal by ballot. The penalty proposal is accepted as long as it is agreed by the majority of all disciplinary commission members.

Article 2 Final provisions

- (1) These Disciplinary Regulations were approved pursuant to Section 9 para 1 b) by the Academic Senate of BUT in April 6, 1999.
- (2) These Disciplinary Regulations come into force in accordance with Section 36 para 4 of the Act on the day they are registered by the Ministry for Education, Youth and Sports.
